Downs Report:

- 1. P. 11 of the Report currently reads: "Mr. Downs had TCE exposure at Tarawa Terrace that ranged from 1-3 ug/L-months and this totaled 43 ug/L-months over the 19 months at Tarawa Terrace."
 - a. Errata: "1-3 ug/L-months" should read "1-3 ug/L" to be consistent with the report and Dr. Reynolds' charts.
- 2. P. 11 of the Report currently reads: "Mr. Downs also had 9 to 19 ug/Lmonths of TCE exposure at Hadnot Point which totaled 282 ug/L-months cumulative exposure while at Hadnot Point for 19 months."
 - a. Errata: "9 to 19 ug/Lmonths" should read "9 to 19 ug/L" to be consistent with the report and Dr. Reynolds' charts.
- 3. P. 12 of the Report currently reads: "Mr. Downs had exposure to the following concentrations in the water during his time at Camp Lejeune in his 589 days on base: 43 microgram/liters TCE, 939 microgram/liter PCE and 122 microgram/liter vinyl chloride at Tarawa Terrace."
 - a. Errata: "microgram/liters" should read "microgram/liter-months" to be consistent with the report and Dr. Reynolds' charts.
- 4. P. 12 of the Report currently reads: "He was exposed to approximately 282 microgram/liter TCE at Hadnot Point."
 - a. Errata: "microgram/liters" should read "microgram/liter-months" to be consistent with the report and Dr. Reynolds' charts.
- 5. P. 17 of the Report currently reads: "Ingestion of thousands of ppb of TCE is a substantial exposure."
 - a. Errata: "ppb" should read "micrograms" to be consistent with the report and Dr. Reynolds' charts.
- P. 17 of the Report currently reads: "This effect was amplified by the fact that according to Dr. Reynolds, Mr. Downs would have also ingested between 23,000 ppb and 59,000ppb of PCE."
 - a. Errata: "ppb" should read "micrograms" to be consistent with the report and Dr. Reynolds' charts.
- 7. P. 17 of the Report currently reads: "Importantly, this exposure is an underestimate of the cumulative ppb of chemicals that actually entered his body."
 - a. Errata: "ppb" should read "micrograms" to be consistent with the report and Dr. Reynolds' charts.
- 8. P. 19 of the Report currently reads: "Mr. Downs TCE exposure totaled between the two locations was 324 ug/L which was in the lower of the exposure ranges for the low exposure to TCE in Bove 2014a."
 - a. Errata: "ug/L" should read "ug/L-months" to be consistent with the report and Dr. Reynolds' charts.

Tukes Report:

- 1. P. 11 of the Report currently reads: "Using the TechFlow model and assuming the ingestion statistics in Ms. Tukes' deposition, Ms. Tukes was exposed to 5,875 ppb of PCE through ingestion alone."
 - a. Errata: "ppb" should read "micrograms" to be consistent with the report and Dr. Reynolds' charts.
- 2. P. 16 of the Report currently reads: "Bove 2014a used a threshold between low and medium exposure of 45 ppb/L-months."
 - a. Errata: "ppb/L-months" should read "ug/L-months" to be consistent with the Bove 2014a study.
- 3. P.16 of the Report currently reads: "The levels of TCE at Tarawa Terrace during that time were less than 1 ug/L-month."
 - a. Errata: "ug/L-month" should read "ug/L" to be consistent with the report and Dr. Reynolds' charts.
